

Where you live is the foundation of your life. It could influence where your children go to school, as well as your access to healthy food choices, nearby healthcare facilities and leisure activities like parks and community events — just to name a few.

Regardless of your gender identity/expression, you and your loved ones have a right to live where you want to live and to have a place to call home. However, housing discrimination based on gender identity/ expression is still widespread.

Gender Stereotyping



Fair Housing Laws & Gender Identity

The prohibition of discrimination on the basis of sex under the Fair Housing Act may be interpreted to include sex stereotyping which impacts gender identity/ expression.

Local Protections

Some states, and a multitude of cities and counties across the country, prohibit housing discrimination on the basis of gender identity.

Sexual orientation and gender identity/expression are currently protected in the cities of Akron, Canton, and Kent, Ohio. More municipalities are adding protections regularly, so please check with Fair Housing Contact Service or your local municipality for updates

HUD Equal Access Rule

Federal regulations prohibit discrimination on the basis of gender/identity expression, sexual orientation, or marital status in all federally funded housing programs. Examples of federally funded housing programs include subsidized housing, the Housing Choice Voucher Program and FHA Mortgage.

Additionally, single-sex emergency shelters or transitional housing that receive federal funding are required to assign housing placement according to the recipients self-determined gender identity. Inquires regarding a person's sex could be considered discriminatory.
